CASE 716 – REQUEST OF CURT AND CAROL DELIE (OWNERS) AND MATT HEATON (AGENT) FOR A PROPOSED NEW HOME AT 2940 NAGAWICKA AVE (DEL 750.076)

It was noted that the fee had been paid and the proper neighbors were notified. A letter from the building inspector dated September 15, 2005 denying the building permit due to violation of minimum open space requirements was read. The letter from Mr. & Mrs. Delie was read stating that they were applying for a variance of 375 sf on the open space requirement.

There were no letters in the file. No neighbors were present at the meeting.

Matt Heaton and Curt and Carol Delie were present at the meeting. It was clarified that no trees within the 50’ of the waterfront would need to be removed; this is in compliance with the tree ordinance. Curt Delie stated that they have stayed within the setbacks, but it is important to have a three-car garage in order to store items inside. A porch is necessary on the side of the house in order to taper the grade to avoid storm water run-off to the neighbor. M. Heaton noted that the floor plan, the building area, and the garage total 3023 sf and stays within the 30% FAR and allows for 7,000 sf of open space. The decks are what cause the problem with the open space. Visually there is not a lot of impact with these areas.
