Call Common Council Meeting to Order

Mayor Attwell called the Common Council meeting to order at 7:00 PM.

Announcement of Closed Session.

1.) City of Delafield Citizens' Comments

Ed McAleer – 3413 Lake Dr. – Comments are based on history. Middle of 1995 when they put the new City Admin to put together a financial policy. He came in with one and it is the same one we use today. In there, it identified 25% for a rainy-day fund. Everyone on the council liked it. When it was presented as a document for them to consider, it was a placeholder number. It was not the number to be used for contingency. We borrowed against it and eventually in the 2000's got knocked down by Moody's. Future admin got the numbers back up and it has been kept there. Do we really need that 25%? It is not a mandate. It's nice to have but it might not be realistic. Waukesha County has a 15% rainy day fund. He is not suggesting 15%, but what he is asking is that Jackie's proposal to put together a professional group to figure out the finances this should include what % we need and is appropriate. Another comment he wanted to make was about the fire commission. He says he does not want the optional powers item. It works well now with the Chief making the disciplinary determinations. Things are handled internally.

Jim Zahorek – 1948 West Shore Dr – Here to speak about the optional powers. He and his wife have lived here for over 30 years and are pleased with the job the department as a whole is doing. They can handle the day to day. He does not want to see another layer created in government. It is not necessary. He also understands we will be discussing the budget and that we may need to let someone go. If anyone of those people are in fire or police, he would be very against it. We can't afford to compromise public safety. A decision may be made tonight to put a referendum out there. He is sure we can find other areas in the finances where we can maintain our current police and fire budget. The way things are going now with CoVID-19, things are getting serious. We need the police there to protect us. We live in an area of affluence. When there is further separation, you need law and order. You cannot compromise in that area. If you can't put it together by making cuts in other areas, he would like the city residents to consider the referendum.

Mary Daniel – 309 Wisconsin Ave – "As a taxpayer, I would like to speak regarding New Business, item f. Preliminary discussion regarding the 2021 Budget. On the City Website in the 2020 Approved Budget, you will find the City of Delafield 5-year Capital Improvement Program 2020 Budget Moved from the 2020 column to the 2021 column Boat dock for Boat Access to Downtown 128,000. The last Lake Welfare meeting during citizens comments people who live in that area were not in favor of this. On our City Website under the Resources tab is the 1993 Downtown Development Plan which address a possible boat dock on page 31,

which recommends no boat landings should be installed in the Bay area. They comment the ramp at the end of Bleecker St. provides adequate landing for Downtown Delafield. This study was paid for with taxpayer dollars. We should be using resources we have paid for in our planning. Some are not relevant but some are very valid today. Public Tree planting for 2021 22,600.00 Public tree planting, does that money come from the Tree Developers Deposit Fund and it is only used to plant trees. Under annual street improvement program moved from 2020 to 2021 column is Separated path from Genesee St to Hillcrest 78,000.00 With a budget deficit ahead, as a taxpayer, I am pleading with all of you, to not continue spending for Capital Items, except for planting public trees because trees take a long time to grow and boat docks and paths can wait until we get this deficit solved. I realize there is the operating budget and the capital budget, but in the end, it is the bottom line. Projects in the capital budget still have to be paid for. Citizens comments one sided and I wonder is there a forum for questions that taxpayers are asking in a public meeting to have an answer at the following public meeting. It would be a way to improve communication and transparency for taxpayers and City."

Chief Erik Kehl – 115 Main St. – He would like to talk about the possibility of a referendum. On behalf of his department, the demands of the public do not reduce based on funding. He does understand the economy is having issues and he does not have the answers. He has talked about over the years how the number of officers is already lower than the standard. If the residents decide they do not want to support those services, that would give him the answer he needs to move forward and reduce one or more of his services. Costs don't go down over time. He hopes that there is an alternate way to address this issue rather than reduce staff.

Susie MAR Thompson – 700 Milwaukee St. – 3 things: 1.) Thank you to Tom Hafner and Paul Zellner, SEH, and the police department for the stop sign at the corner of Oneida and Main St. The difference with downtown traffic is amazing. 2.) for 6B, flag property talking about sewer. There are a lot of trees. That is the most expensive sewer bill she has ever seen. In Brookfield it was 8-12K. She knows people who have paid 30-40K. To pay over 100K is cost prohibitive. As a City, we should be able to allow people to keep septic. 3.) Thank you for Delafield ID – Thursdays on the Hill. An event the community can embrace. Something that will be fun and safe.

Discussion and possible action regarding request from I.D. restaurant for approval of a series of upcoming community events that are expected to exceed the Waukesha County large gathering recommendation. Presentation to be made by a representative of I.D. restaurant with their plan to provide for appropriate social distancing, hygiene accommodations, and precautionary measures to safely accommodate the proposed large gathering size.

Bailey Fornell – Walk thru safety plan for Thursdays on the hill. Setup 3 bars. 100-150 people. Signage for social distancing. Sanitation stations 6+3. Stanchions around

performers to prevent crowding. Additional staff. All food indoors to fall under health inspector system. Served carry out style. Wipe down tables. Masks encouraged inside. Restrooms and doorways cleaned every 30 minutes.

b. Discussion and possible action to consider providing exceptions to the mandatory sewer connection requirements of Section 50-4(d)(3) of the City of Delafield municipal code due to hardships involved with the length of connection or other factors that would make the connection to be not financially feasible, as requested by David Wippert, 2480 Nagawicka Road, and Alderperson Saloga.

Tom Hafner – Dave and his real estate agent would like a variance for the mandatory sewer hookup. Tom said there was no variance. Tom stated the requirement. There is an exception for up to 10 years if they had a cert from the county. renovation or sales would remove the exception. There is nothing in the code for variance for this item. Their request would need to be completed with an ordinance at a future meeting.

David Wippert – 2480 Nagawicka Rd – with intentions of moving. The cost for this would be well over \$114,000. This is because it is 20 feet down, under water, and there is no stub at the road.

Aicher talked about the Hirschman lane property.

Kasun talked about SJMA taking down a house because the cost to put in sewer was more than the house.

Aicher would like us to look at the code and determine these exceptions circumstances.

Saloga explained the lot and the distance. Half the cost of the improvement if the cost of the T.

Wayne Dehn thinks this item should go to the CDA. Tom clarified they can only make a recommendation.

Item to be postponed to another date until further information can be gathered and shared.

c. Discussion and possible action, as requested by Alderperson Valde, regarding recent clear cutting at the Bleeker Street Boat Launch and along the shore of the Bark River near the Fish Hatchery Building and consideration of putting up signage or explanation.

Tom Hafner to merge F and G together. We are waiting on additional numbers from the State and other entities. Gathering more data on payments from outside entities both in 2020 and 2021. We are also looking at the changes in contributions to the fire department. Asking to meet the first Monday in August with a preliminary budget. Also, will speak about the referendum question. He is looking at 2 separate budgets for the council consideration. One with an approved referendum and one without.

Grimmer wants to clarify we will have a fund balance of 20%.

Tom clarified we are currently at 23% which is about 1.5M. Tom asked about hotel projections for the next few years and they are not projecting. The only information we have from them is 1st quarter. By the end of July, they need 2nd quarter results to the city.

Grimmer to clarify that we were looking at \$350k.

Tom said with CoVID and changing contributions it will be significantly more.

Kent suggested a special committee that would educate the city residents on the referendum. Have a one sheet handout to simplify things.
